

The regular meeting of the Greenwood Township Board of Trustees on July 12 2016 was called to order by Supervisor Terry Gill at 7:30 p.m. at the Greenwood Township Hall, 9025 Yale Road. Other board members present were Clerk O'Brien, Treasurer Ramsey and Trustees Jonseck and Stewart along with Zoning Administrator Jeffery Kern, Sheriff Tim Donnellon and 8 residents. The minutes of the previous Regular meeting on June 14, 2016, the treasurer's report and the outstanding bills were approved as presented. O'Brien requested that the line Correspondence – Foreclosure List be removed from the agenda.

The fire department report was approved as presented. Gill discussed the replacement of the dipstick for Truck 36 as an emergency repair.

The Zoning Administrator and Supervisor Gill discussed an enforcement issue.

In citizens comments a member of the Greenwood Little League board requested the use of the baseball field for fall ball beginning September 11, 2016 and ending October 16, 2016 for 6 consecutive Sundays. Stewart made a motion to approve. Jonseck seconding. Motion carried 5-0.

In new business Sheriff Tim Donnellon was present to discuss the St Clair County Drug Investigation and Prosecution task force millage. The presentation was very informative regarding the statistics of the current drug related problems in St Clair County. Gill made a motion to approve Kevin Lovik Builders to replace 21 parking posts. Stewart seconding. Roll Call: Jonseck – yes; Gill – yes; Ramsey – yes; Stewart – yes; O'Brien – yes. Motion carried 5-0. O'Brien made a motion to approve the purchase of 2 additional tables for the Township Hall. Jonseck seconding. Motion carried 5-0.

In citizens comments the former deputy treasurer discussed the removal of his name for the township safety deposit box.

The regular meeting was recessed at 8:12 p.m.

The special meeting of the election commission was call to order by Clerk O'Brien at 8:12 p.m. Other members present were Supervisor Gill and Treasurer Ramsey along with 9 residents, Zoning Administrator Jeff Kern and Sheriff Tim Donnellon.

O'Brien made a motion to appoint Joann Bilinski, Melanie Ripenbark, Kimberly DePelsmaeker, Megan Ripenbark, Breanna Ripenbark as election inspectors for the August 2, 2016 Primary Election. Gill seconding. Motion carried 3-0. O'Brien made a motion to appoint Joann Bilinski as the Chairperson for the August 2, 2016 Primary Election. Gill seconding. Motion carried 3-0. O'Brien made a motion to appoint Melanie Ripenbark and Joann Bilinski as the Receiving Board for the August 2, 2016 Primary Election. Gill seconding. Motion carried 3-0.

O'Brien made a motion to adjourn the Special Meeting of the Election Commission. Gill seconding.

Meeting adjourned at 8:14 p.m. Motion carried 3-0.

The regular meeting was brought back into session at 8:14 p.m.

Jonseck made a motion to adjourn. Ramsey seconding. Motion carried 5-0.
