

May 10, 2016
Greenwood Township –Regular Meeting Minutes

The regular meeting of the Greenwood Township Board of Trustees on May 10, 2016 was called to order by Supervisor Terry Gill at 7:30 p.m. at the Greenwood Township Hall, 9025 Yale Road. Other board members present were Clerk O'Brien, Treasurer Ramsey and Trustees Jonseck and Stewart along with Zoning Administrator Jeffery Kern and 9 residents. The minutes of the previous Regular meeting on April 12, 2016 were approved as presented.

In correspondence Stewart discussed addressing Little League regarding games on Board Meeting nights.

The treasurer's report was approved as presented.

O'Brien added the annual fire contract to Kenockee Township be added to outstanding bills. O'Brien made a motion to approve the outstanding bills. Ramsey seconding. Motion carried 5-0.

The Fire Department Report was accepted as presented. Gill made a motion to purchase 10 pails of foam for Truck #36 in the amount of \$1,300.00 after the foam line is repaired by Apollo. Stewart seconding. Motion carried 5-0. Gill made a motion to approve having the drop line installed at the fire hall by Ralph Munro for \$250.00. The striping for Truck #36 will be discussed at next month's meeting.

The Zoning Administrator said he had nothing to report this month.

No citizens comments.

In new business Ramsey discussed the need for additional safety play mulch on the playground. The discussion will be held at the June meeting after estimates have been received. Gill discussed a safety issue in the sidewalk in front of the Township hall. The board gave Gill permission to get quotes and treat as an emergency repair. Gill made a motion to approve Midwest Metal Construction to replace the roof on the pavilion with a shingle roof. Stewart seconding. Ramsey abstaining. Motion carried 4-0. O'Brien made a motion to approve the 2016 St Clair County Parks and Recreation Request for Local Millage Distribution. Ramsey seconding. Roll Call: Jonseck – yes, Gill – yes, Ramsey – yes, O'Brien – yes, Stewart – yes. Motion carried 5-0. Stewart made a motion to purchase 100 chairs and 10 tables for the Township Hall. Gill seconding. Roll Call: Jonseck – yes, Gill – yes, Ramsey – yes, O'Brien – yes, Stewart – yes. Jonseck made a motion to purchase up to 3 racks not to exceed \$1,000.00 for chair storage. Stewart seconding. Motion carried 5-0.

No citizens comments.

Jonseck made a motion to adjourn. Ramsey seconding. Motion carried 5-0.
