Greenwood Township –Regular Meeting Minutes

The regular meeting of the Greenwood Township Board of Trustees on January 10, 2017 was called to order by Supervisor Douglas Nowicki at 7:30 p.m. at the Greenwood Township Hall, 9025 Yale Road. Other board members present were Clerk O'Brien, Treasurer Ramsey and Trustees Roberts and Krikorian, Zoning Administrator Jeff Kern along with 12 residents. Nowicki made a motion to approve the minutes of the previous Regular meeting on December 13, 2016. Ramsey seconding. Motion carried 5-0.

Ramsey added the mailing of assessment notices to the agenda under new business. Roberts made a motion to approve the agenda with one addition. O'Brien seconding. Motion carried 5-0.

The treasurer's report was approved as presented.

O'Brien made a motion to approve the outstanding bills. Ramsey seconding. Motion carried 5-0.

The fire department report was approved as presented.

The enforcement officer's report was approved as presented.

The Zoning Administrator stated there would be a Planning Commission meeting and Public Hearing on January 18, 2017. Geronimo has applied for a special use permit to install a anemometer.

No citizens comments.

In old business the furnace at the fire hall has been repaired. The township received a quote to replace the water softener at the hall. Supervisor Nowicki discussed looking into the repair further and discussing at a later meeting.

In new business Nowicki made a motion to appoint Mike Walsh, Mark Begerowski, Robert Carrier as an alternate and Scott Ramsey as an alternate to Board of Review. O'Brien seconding. Roll Call: Krikorian – yes; Nowicki – yes; Ramsey – yes; O'Brien – yes; Roberts – yes. Motion carried 5-0. Nowicki made a motion to appoint Mike Schaefer as an alternate for Zoning Board of Appeals. Roberts seconding. Roll Call: Krikorian – yes; Ramsey – yes; Nowicki – yes; O'Brien – yes; Roberts – yes. Motion carried 5-0. Nowicki made a motion to appoint Heather Stewart to Planning Commission for a 3 year term. Ramsey seconding. Roll Call: Roberts – yes; O'Brien – yes; Ramsey – yes; Nowicki – yes; Krikorian – yes. Motion carried 5-0. Ramsey made a motion to install chevrons on Truck #36 in the amount of \$102.56 for the Township Share and \$1000.00 from Kenockee Township Fire Department. Roberts seconding. Motion carried 5-0. Nowicki made a motion to purchase 3 hallogen bulbs and a headlight for Truck #36 as long as all are under \$50.00. Ramsey seconding. Motion carried 5-0. O'Brien made a motion to approve Board members attendance at the St Clair County Chapter of the MTA dinner. Ramsey seconding. Motion carried 5-0. O'Brien made a motion for Board of Review members to attend training at Sanilac County or Port Huron. Nowicki seconding. Motion carried 5-0. O'Brien made a motion to approve repairing or replacement, if necessary, of the lights in the Zoning Administrator's office. Roberts seconding. Motion carried 5-0. Nowicki made a motion to approve using an outside

company to print and mail assessment notices not to exceed \$811.79. Ramsey seconding. Motion carried 5-0.

In citizens comments questions were asked regarding the gravel mixture.

Nowicki made a motion to adjourn. Ramsey seconding. Motion carried 5-0.
