

April 10, 2018
Greenwood Township –Regular Meeting Minutes

The regular meeting of the Greenwood Township Board of Trustees was called to order by Supervisor Nowicki at 7:30 p.m. at the Greenwood Township Hall, 9025 Yale Road. Board members present Supervisor Nowicki, Treasurer Ramsey, Clerk O'Brien, Trustee Roberts and Trustee Krikorian along with 8 residents. Also present were Zoning Administrator Jeff Kern and 4 Kenockee fire board members.

Clerk O'Brien made a request to add the purchase of a computer for the Treasurer to the agenda as item 13.

Nowicki made a motion to approve the minutes from the previous meeting of March 13, 2018. Ramsey seconding. Motion carried 5-0.

In correspondence Nowicki discussed receiving correspondence from SEMCO, grant information for websites and the St Clair County Emergency services breakfast.

Nowicki made a motion to approve the treasurer's report. O'Brien seconding. Motion carried 5-0.

Ramsey made a motion to approve the monthly bills as presented. Roberts seconding. Motion carried 5-0.

The fire department report was approved as presented.

The Zoning Administrator stated that the Planning Commission will be meeting on April 18, 2018 at 7:30 p.m.

In new business O'Brien made a motion to approve the contract for fertilization with Ameriscapes. Ramsey seconding. Motion carried 5-0. Nowicki made a motion to approve the maintenance by Apollo on the Jaws of Life. Ramsey seconding. Motion carried 5-0. Nowicki made a motion to approve the annual inspection of the fire extinguishers by Thumb Extinguishers. Krikorian seconding. Motion carried 5-0. Nowicki made a motion to approve the PA116 for Partlo. O'Brien seconding. Motion carried 5-0. Nowicki made a motion to approve 2018-1 Amendment to the Wind Ordinance with a spelling correction and an additional phrase. Roberts seconding. Roll Call: Roberts – yes; Krikorian – yes; Nowicki – yes; O'Brien – yes; Ramsey – yes. Motion carried 5-0. Nowicki made a motion to correct the 2018-2019 Budget Amendment due to an addition error. O'Brien seconding. Motion carried 5-0. O'Brien made a motion to approve Resolution 2018-4 to request for Federal and State bridge replacement funds for Duce Road over Jackson Drain. Ramsey seconding. Roll Call: O'Brien – yes; Ramsey – yes; Nowicki – yes; Krikorian – yes; Roberts – abstaining. Motion carried 4-0. Nowicki made a motion to approve Resolution 2018-5 to request for

Federal and State bridge replacement funds for Comstock Road over Eves Drain. O'Brien seconding. Roll Call: Krikorian – yes; Nowicki – yes; Ramsey – yes; O'Brien – yes; Roberts – abstaining. Motion carried 4-0. Nowicki made a motion to approve the 2018 Road Contracts. Ramsey seconding. Roll Call: Nowicki – yes; Ramsey – yes; Krikorian – yes; O'Brien – yes; Roberts – abstaining. Motion carried 4-0. O'Brien made a motion to approve Yale Electric to repair or replace the emergency exit sign at the front door. Roberts seconding. Motion carried 5-0. Nowicki made a motion to approve the purchase of a paper shredder for the office. Roberts seconding. Motion carried 5-0. The Kenockee Fire Board was present to discuss the renewal of the Kenockee Fire Contract. A presentation was given by the fire board and time was given for discussion and questions. O'Brien made motion to purchase a computer for the Treasurer up to \$1000.00. Nowicki seconding. Motion carried 5-0.

In citizen's comments questions were asked regarding the solar project, questions regarding the chloride application and questions for the Kenockee fire board.

Nowicki made a motion to adjourn, with Ramsey seconding. Motion carried 5-0.
